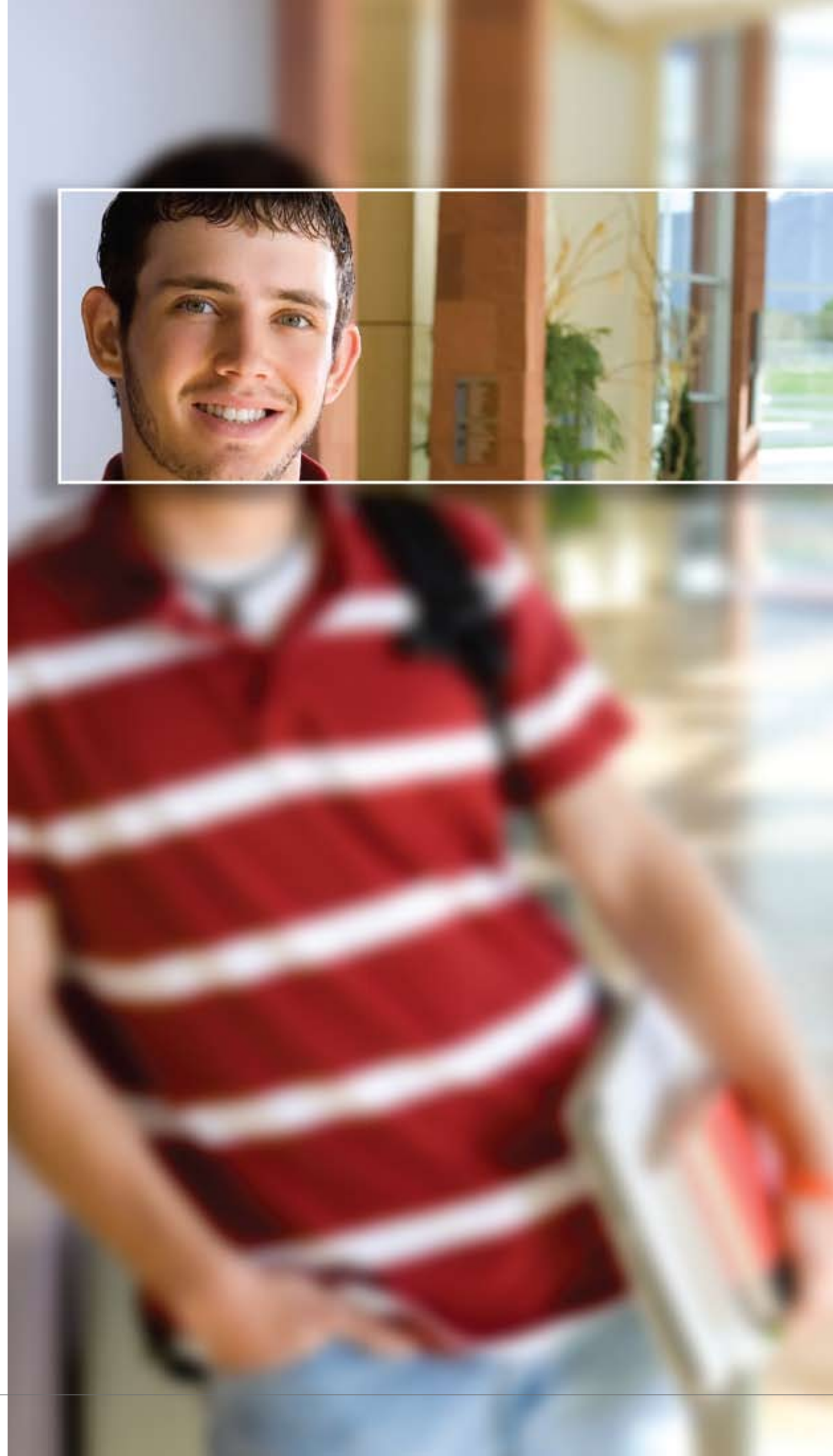

With insufficient government funding, significant reductions and changes in Medicaid, and a challenging financial year, managing a balanced budget is by far the most difficult strategic directive before us as an agency. Maintaining the highest, quality client care remained a focus as we made significant administrative achievements including enhancing employee benefits which helped to reduce turnover; improving food and housekeeping services which helped increase client satisfaction to 93%; and successfully being reaccredited for another three years by the Joint Commission.

Meeting the mental health and substance abuse needs of our community can be a daunting task, but it is one that we tackle every day. Through the addition of new programs, expanding our core services, seeking new funding sources, diversifying revenue and positioning ourselves for expansion, we made progress here as well. As we look into the future, we realize how much more needs to be done - yet our focus remains strong.

On behalf of the entire Board of Directors, our tireless staff and volunteers, and the thousands of individuals who turn to us for help and hope, we thank you for sharing in our commitment to improving the lives of those in need.

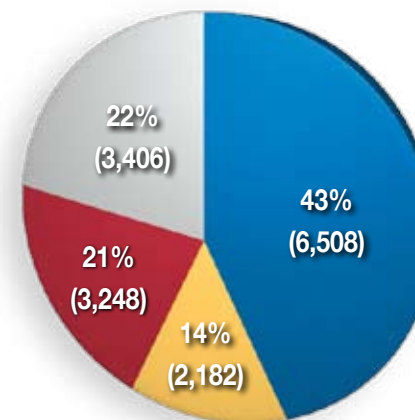

## CLIENT SUCCESS STORY: } Adult Mental Health }

**S**teve has managed bipolar disorder for most of his life reporting that his best defense against the symptoms “has always been hard work”. Until recently retiring as an executive of a large aerospace engineering firm, keeping busy was never a challenge. But over the course of a year, he dealt with the loss of his father and ensuing family fight over his estate and the accidental death of a beloved pet. He began isolating from others and entered into a “deep, sad fog”. He shares, “I was in a constant state of extreme depression. I felt agitated all the time and was taking on all of the world’s problems as my own. I saw no way out and began to feel suicidal.”

His wife brought him to the David Lawrence Center’s Crisis Stabilization Unit where he received medications to stabilize his mood. He says, “In just a few days, I began thinking clearly and was able to stop looking inward and start thinking about my wife, my daughter and all the things I still wanted to accomplish.”

Steve now attends outpatient counseling at Life Works of Naples, the Center’s affiliate private behavioral healthcare practice, where he is working through current stressors in his life and delving into childhood traumas that he never processed. He is setting goals, looking to start a new business, researching consulting opportunities and finding ways to stay social. Both Steve and his wife believe that without the help they received at the Crisis Unit, he would not be here today.

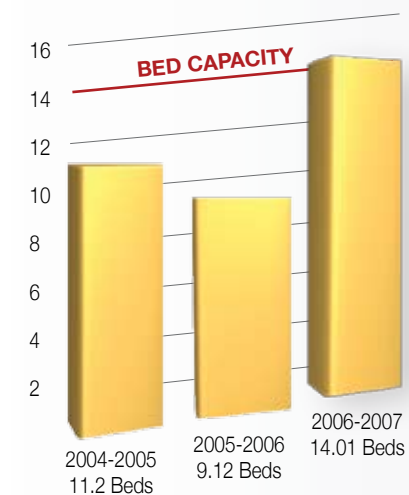


# FOCUSED ON: Adult Mental Health

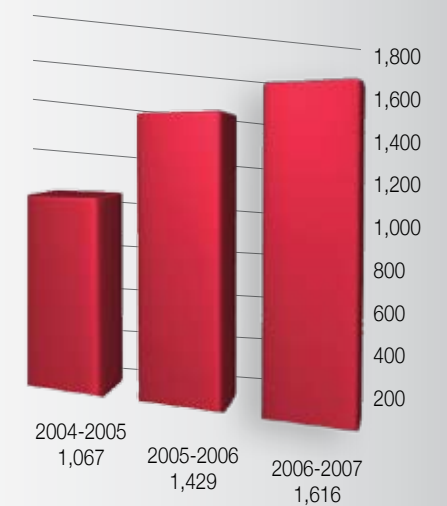
**M**aking up nearly 50% of our business, adult mental health services is at the core of what we do. These services focus on rebuilding lives, restoring stability and providing the tools needed to step toward the future with courage and hope. Keeping this focus at the forefront of our program development, this year we partnered with the community on several initiatives designed to divert people with a mental illness from the criminal justice system including the development of a competency to stand trial education program, a mental health court and crisis intervention training for law enforcement. As a result of these efforts, the Center saw a significant increase in the number of emergency assessments and inpatient admissions to the already overcrowded Adult Crisis Stabilization Unit. The Center continues to look for ways to afford the desperately needed expansion of the Unit. After three years of soliciting their support, the Florida Legislature provided \$300,000 towards this goal. Managing the Unit at or above capacity without impacting the quality of care, was a huge accomplishment and staff are to be commended for their patience, commitment and compassion.

The Center also improved access to adult mental health outpatient services by implementing a new customer friendly Open Access System for routine, urgent, emergent and brief therapeutic treatment. In this traditional Walk In Clinic model, individuals can be seen and accessed by a qualified clinician on the same day services are requested eliminating long wait times for appointments. This new system and the expansion of Life Works of Naples increased outpatient services, gave clients more options for treatment and helped diversify revenue sources.

OUTPATIENT MEDICAL SERVICES**



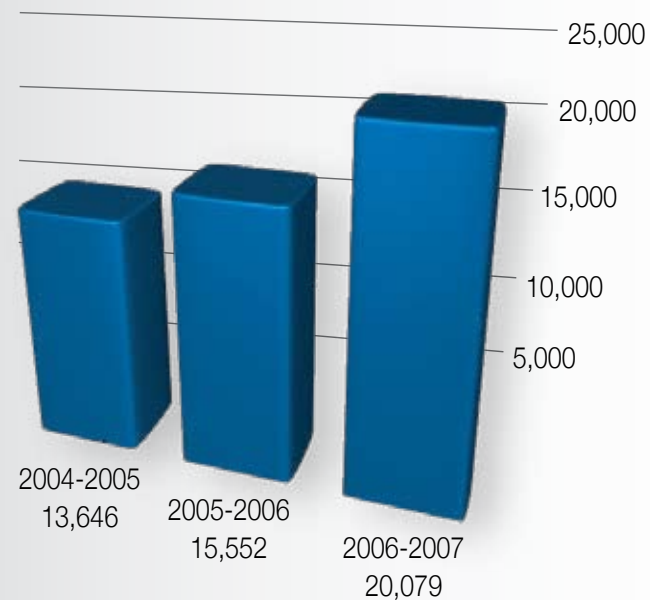
# FOCUSED ON: Adult Substance Abuse

People abuse drugs and alcohol for varied and complicated reasons, but it is clear that our families, friends, co-workers, businesses and our community pays a significant cost. The toll of this abuse can be seen in our hospitals, emergency rooms, jails and prisons. Sadly, in extreme cases, children and spouses are abused and neglected and death can occur. But David Lawrence Center is committed to breaking the cycle of abuse focusing on helping individuals with substance abuse problems gain stability, restore relationships and become productive members of their families and our community.

Our recovery programs have a unique ability to address the mental and emotional issues and addictive behaviors that contribute to an individual's problems. We take a personalized approach and include family therapy and aftercare services to provide the best opportunities for success.

In order to provide more flexible addiction recovery services and make treatment more accessible to everyone in need, this year the Center expanded the Adult Day Treatment Program and increased awareness of treatment services by hiring a new Substance Abuse Outreach Specialist. This employee encourages, educates and engages prospective clients who show a potential need for substance abuse services. In addition, he advocates on behalf of clients with legal professionals and the court system. These improvements have increased substance abuse services making recovery possible for more people than ever before.

## CLIENT SUCCESS STORY: Adult Substance Abuse

Laura, now 53, started experimenting with drugs in the 70's when the use of marijuana, cocaine, acid and other illegal substances was widespread during that rebellious time. Cocaine remained her drug of choice off and on for the rest of her adult life. She describes herself as a "sporadic, heavy user" turning to cocaine when she was stressed and wanted an escape. Laura never felt she was addicted or had a drug problem because she could still function. She recalls, "I remember staying up for three days straight and still going to work and doing my job." That all ended when she was randomly drug tested at work where she had been employed for over seven years. Because her company had a Drug Free Work Place Policy and supported their employees through treatment, she was faced with a choice – get clean and keep your job or be fired – an easy decision in her mind. She says, "This was a real wake up call. I've worked hard to get where I am at and invested in my future. Drugs aren't worth it. I realize how lucky I am to have had this choice."

She was referred to David Lawrence Center's substance abuse intensive outpatient counseling where she spent three months learning about addiction, denial and understanding that it is an illness. She then spent another three months in relapse prevention attending group therapy and developing her personal plan to stay clean. Today, she has a sponsor and remains clean and sober by voluntarily attending the Center's aftercare group therapy classes and 12-step meetings in the community. She adds, "At first I was angry and scared about treatment, but everyone at David Lawrence Center made me feel comfortable. They were open minded and never judged me. Over the course of treatment, my attitude has totally changed. I am a calmer, more positive person and now I want to stay clean."



## CLIENT SUCCESS STORY: Children's Mental Health

Since the young age of 4 when he tragically lost his best friend, Charlie has been experiencing extreme behavioral issues. Despite the best efforts of an outpatient counselor and a combination of ADHD, antipsychotic and bipolar medications, his behaviors got worse and he was kicked out of every day care.

By the time he began working with a David Lawrence Center therapist several times a week in an intensive community based setting, his teachers deemed him a trouble maker writing more than 200 referrals in one school year. He was verbally aggressive, impulsive, brought weapons to school, refused to complete homework assignments and often engaged in physical altercations with teachers and other students. His mother, a single parent with three children, was pushed to the edge. She shares, "I couldn't keep a job because of the constant calls from the school. I was having panic attacks and was very stressed."

Through a combination of parental guidance, positive reinforcement, learning what triggers his anger and how to cope with it appropriately, and finally being diagnosed with an emotional handicap and getting him into a smaller, special education class, he has gone from trouble maker to the Dean's list.

Now 12, Charlie sees an outpatient counselor on a monthly basis and is effectively managing the symptoms of ADHD with medications. His mother boasts proudly, "He has friends now, is making better choices, volunteers at church and can recognize his own success. I am extremely thankful for the help we have both received. I never could have done it on my own."

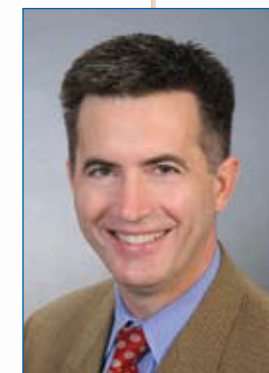
# FOCUSED ON: Children's Mental Health

Meeting the unique mental health needs of children, adolescents and their families is a high priority at the David Lawrence Center. Now more than ever, parents, guardians, law enforcement and the school system are looking to the Center for help with children suffering from severe emotional, behavioral and psychiatric disorders. In order to better deal with these specialized issues, this year the Center hired a new Medical

Director, Dr. Brent Lovett, who is board certified in both children's and adult psychiatry. This is the first time in the Center's history our Medical Director has been dually trained. His focus for the future of children's mental health services is to find creative ways to meet the shortage of services available and recruit additional, trained professionals in children and adolescent issues.

From community outreach and prevention activities, to outpatient counseling and residential treatment, the David Lawrence Center provides a comprehensive array of interventions focused on making children and families feel safe and cared for. Every day, parents learn the skills they need to respond to their children with understanding and patience, children learn proper social skills and how to deal with their emotions and adolescents are taught to manage the symptoms of their illness with self control and appropriate coping skills. The David Lawrence Center is focused on creating the foundation upon which children and their families can create an emotionally happy and healthy life.

# FOCUSED ON: Children's Substance Abuse

Illegal substance abuse among children in Collier County is a real and growing problem. Access to alcohol, prescription medications and illegal drugs is easier than ever before. This year, the Center focused on developing new management structures that strengthened the referral and linking process within the court system improving access to the Center's substance abuse prevention, intervention and treatment programs for troubled youth. Outreach efforts and increased publicity helped raise awareness about the Juvenile Drug Court program as an alternative to incarceration for youth trapped in the criminal justice system due to their addictions. Enhancements made to the Juvenile Assessment Center allowed parents to access free substance abuse assessments and more than 135 free drug screens to help monitor and prevent drug use in their children.

In addition, the Center continued to focus energy on programs that help prevent juvenile substance abuse. Our series of psycho-educational group therapy classes for both juveniles and parents with substance abuse problems seek to break the cycle of addiction by providing an education on drug awareness, social and legal consequences and how to make positive choices that will help children and families appropriately overcome obstacles and prevent them from turning to drugs and alcohol.

## CLIENT SUCCESS STORY: Children's Substance Abuse

By the time Kelly was 15, she was hanging out with the wrong crowd at school abusing cocaine, prescription pain killers and marijuana between classes. She says, "I was always around it. When my friends didn't have it, I would steal money from my parents, brother and sometimes my friends to pay for it." Before long she was smoking pot everyday during school and sneaking out on school nights to do drugs. She had D's and F's and admits she had lost all respect for herself. Her parents had tried everything – random drug testing, therapy, restriction – nothing seemed to work. When her tests came back positive, they took away privileges so she would run away – sometimes for weeks at a time. They finally had her arrested and presented her with an opportunity to participate in Juvenile Drug Court so she could turn her life around.

Kelly, like many other substance abusers, has a co-occurring mental illness and takes medications for ADHD and a mood disorder. These conditions compounded her defiance, rebellion and poor self esteem. In Drug Court she addressed these issues with individual and family counseling, group therapy and regular 12-step meetings. Judicial supervision kept her behavior in check. When her grades dropped, they knew. When she stayed out past curfew and got drunk, she was put in jail for two weeks. Over the course of a year and half in the program, she learned that she was never going to get anything accomplished and would never get the trust of her family back if she continued on this path.

Kelly shares, "Drug court was a life changing experience. It totally changed my attitude and made me look inside myself. It gave me my life back – a chance to start over. I was able to graduate and now I have a future. I feel like a huge burden has been lifted." She attributes her success in the program to the overwhelming support she received from her parents, her case manager and the entire Drug Court panel for believing in her.


# FOCUSED ON: Meeting the Needs of the Center
